### VI. Budget Proposals Released

- Kathy Eckstein: House budgeted in Medicaid caseload growth, Senate didn't. Doesn't look like they're funding "welcome mat" kids in the base budget, as HHSC did in their LAR, but we will need to confirm that . And huge reduction in CHIP without corresponding/expected increase in Medicaid. Will need LBB to explain the thinking.
- Anne: Kids 6-18 100-133% FPL are moving to Medicaid from CHIP.
- Kit: Asset test going away, lots of kids who qualify by income but not by assets will now be eligible.
- Anne: Newborns? Not sure. Sendero/Michelle: Stated that it appeared that CHIP Perinate coverage was being terminated prior to moms' post-partum visits and the newborns' Medicaid becoming effective.
- OTA will stay grounded on their issues, even as session moves on.
- Some funds for graduate medical programs were restored in both bills. The Physician Education Loan Repayment Program is appropriated \$34 million in 2014-15, compared to \$6 million in 2012-13. Funds eliminated in 2012-13 (\$5 million) for the Primary Care Residency Program were not restored. Funding is the same as 2012-13 for the Family Practice Residency Program (when funds were reduced by 74%).

# VII. Other Legislative Issues to Date

- Legislative Budget Board's GEER: Section on letting counties do MedEx. Numbers don't match up with HHSC's but not to worry.
- Arizona's Jan Brewer's Medicaid expansion proposal includes language that state can back out if feds reduce funding. Similar to Texas CHIP statute language included in 1999 passage.
- Discussion of possible XIX/MedEx mergers and expansion possibilities.
- MH spending proposal are flat. Katherine Ligon, Clayton Travis, others looking at it.

- Balance between showing Medicaid expansion savings and having funding cut and diverted precipitously, vs. program that was underfunded already and now won't get its full funding.
- Lauren Dimitry. Pg. 8 GEER has soda fee!
- Kathy: Medical Transportation program. Full risk broker contracts in DFW. Problems not only with them. Been working with HHSC. Not going fast. Some technical changes we're promoting. Auto-check driver's licenses and insurance. Data sharing in bill. HHSC also plans on moving to statewide full risk broker. Helen: HHSC ombudsman office was terrible. Kathy: have a trouble-shooter now. And working on language to make exception to policies implemented in last six months to give exceptions for some diagnoses like cancer or whatnot so you don't need to get reapproved month by month. Meanwhile, Sen Nelson bill would move med trans into each Medicaid HMO.
